#### ARGENTINA & HONDURAS: As

part of a new podcast series, Alejandro Pavón from Honduras and Agustina Borre from Argentina shared their experiences engaging Minnesota children in learning about cultures through the Classroom Connection program.



#### MOROCCO, NIGERIA, UGANDA: An

expert panel of visiting health professionals from countries including Uganda, Morocco, and Nigeria discussed combating infectious disease during a Global Social and public presentation.



GERMANY: In a new Sustainable Development Roundtable series, Minnesota businesses connected with a visiting delegation from Germany to discuss new technologies and ideas surrounding green energy.



UKRAINE: To deepen Minnesota's understanding of Ukraine, we launched a new virtual diplomacy program between high school students from Minnesota and Ukraine and welcomed former Ambassador to Ukraine Marie Yovanovitch for a public program.



CHINA/PACIFIC:

At a public event, Principal Deputy Assistant Secretary of State Kin Moy briefed Minnesotans on the U.S. Indo-Pacific strategy regarding China.



#### PUBLIC EVENTS

Through free and low-cost public events, we connect Minnesota with the global community and offer timely information on topics of international importance. From local foreign policy experts to visiting ambassadors and diplomats, over 75 events engaged more than 5,000 participants in understanding world trends and making global decisionmakers accessible to our community.

#### K-12 EDUCATION

Our education programs ignite the global curiosity of our youngest learners. The Academic WorldQuest knowledge competition gathered 27 high school teams together to challenge students' global understanding. Classroom Connection brought the world's cultures to more than 1,500 school children through 3,480 contact hours of learning.

#### PROFESSIONAL EXCHANGES

This past year, over 300 emerging leaders from around the world visited Minnesota for professional and cultural exchange. These professionals met with government officials, nonprofit executives, education professionals, and corporate leaders to share best practices and experiences. These visiting professionals from over 100 countries are participants in the U.S. State Department's International Visitor Leadership Program and other exchange programs.

#### INTERNATIONAL STUDENTS

Building on our origins of welcoming international students over 70 years ago, we've reenergized our efforts and reached over 1,000 international students this year. More than 40 events and outings offered support, Minnesota cultural insights, and career advice to students from 26 universities and colleges.

#### DISCUSSION GROUPS

The Great Decisions discussion program, a collaboration with the national Foreign Policy Association, creates grassroots discussion groups with local community leaders designed to make critical foreign policy conversations accessible to people throughout the state. Over two dozen groups came together this past year to host nearly 200 discussions with local experts identified by Global Minnesota, fostering important debate and discussion on the key foreign policy topics of our time.

Our business roundtables and networking events afforded access to ideas and expertise from countries like Germany and Finland — each of whom who are leading the way in sustainable development and can offer insights on new best practices.

Today's information landscape can omit critical context. Global Minnesota provides trusted information, thoughtful insight, and expert analysis on major global events and trends. The Great Decisions discussion program brings local foreign policy professionals to people from all backgrounds to discuss important issues. Through youth engagement, we inform the next generation of Minnesota's global citizens. Classroom Connection inspires our littlest learners with fun and informative cultural lessons. Academic WorldQuest prepares high school students for a globally-connected world, while international student workshops provide insight into career opportunities.







### LEADING IN GLOBAL ENGAGEMENT



The world is complex and changing quickly, but our shared commitment to intercultural relationship building remains constant. Our professional exchanges bring emerging leaders from a variety of backgrounds to Minnesota to share best practices with local experts to create a brighter future for all. This past year, a group of prosthetics experts from Ukraine met with local prosthetics manufacturers to share their experiences and build relationships to better serve the substantial need arising in Ukraine. Our events also engage the wider diaspora within Minnesota through partnerships with the local Ukrainian and Somali communities.

This foundation of global connection, information, and engagement has positioned our community to move forward with confidence. We are building new initiatives and expanding current programs to reach more of Greater Minnesota and engage more people across our community.
